The utility fund statement of net position shows total assets to be a little over 2.8 million with total net position being almost 1.5 million which is a decrease of about \$100,000.00 from the prior year. The general fund budget to actual schedule will show that the expenditures were under budget by about \$100,000.00 which is very good. This was a single audit because the city expended over \$500,000.00 in federal funds this year. Councilman Clegg DeWalt asked what Mrs. Sollock perceived to be the \$390,000.00 increase in the general fund. Mrs. Sollock stated it could have been the grants that caused the increase but that she would double check on that.

Mr. Bartlett said there was a little over \$108,000.00 left in the budget that had not been spent out of the \$750,000.00. The city decided to do a Fire Lane which would be on the western side of the large manufacturing building. Mr. Bartlett stated they notified 15 contractors personally but only one bid came in for the project. Crockett Construction's bid was \$122,071.25 which was over the budget. Mr. Bartlett and Crockett Construction went over the bid to see if they could reduce the bid and they were able to reduce it to \$114,000.00. Mr. Bartlett's company decided to donate \$3,000.00 and XG Ventures decided to make up the difference of \$3,231.00 to get it back to the \$108,000.00. Mr. Bartlett is asking for the Council to award the bid to Crockett Construction for \$122,071.25 contingent upon the fact the funds get returned to construction, XG Ventures writes a check and that the change order is immediately processed to refute the contractor's cost. Mayor Pro-Tem Wayne Huffman made the motion to award the bid to Crockett Construction. Councilman Clegg DeWalt 2<sup>nd</sup> the motion. All remaining members voted yea. Motion carried.

- B. Discussion and Action with Michael Lewis from Lewis Air Conditioning concerning the air conditioning at the Library. Mr. Lewis stated he has the air conditioning running to the best of its ability with the coil that was built for the design of the old air handler. It is maintaining 70 degrees but is running longer then it should because the delta t is not where it needs to be. His pressure chart and pressure design for that system is perfect but the coil design is not adequate for the R410, it is not functioning properly with the new Freon. He wants to put a new air handler in but the problem is getting it in the attic. Mr. Lewis can get a 12 ½ ton air handler from trane to match up with the existing new unit that is outside, this will make the life of the system longer. If he changes the air handler and copper out then he can get everything adequate to the design of the unit and get the delta t where it needs to be at which will make the life of the system longer plus the electric bill will be less because it will cycle on and off like it is suppose to. The unit change out on his side will be \$6,500.00. If he can get the unit up by just disassembling the stair case he can separate the air handler. He can cut up the old air handler and get it down with no problem. Getting the new air handler in the attic is where the problem may occur. Mr. Lewis has talked with Matt Morrison on getting the new air handler in and Mr. Morrison said if they could just take the air handler apart and put it back together once it is in the attic, the cost will be approximately \$500.00. If they have to drop it and redo the trim and paint it could be up to \$2,000.00. Mayor Pro-Tem Wayne Huffman made the motion to approve the proposal and hopes it stays under \$7,000.00. Councilman Clegg DeWalt 2<sup>nd</sup> the motion. All remaining members voted yea. Motion carried.
- C. Discussion and Action regarding installing the generator at the City Barn. Mayor Slaughter stated the city changed out some of its generators 3 years ago and the city barn received one of the used generators which has not been installed yet. All Around Electric gave 2 bids for installing the generator, one bid was for \$3,979.92 with copper wiring and the other bid was for \$3,688.30 with aluminum wiring. Mayor Slaughter suggested to install the generator in the upcoming fiscal year instead of the current fiscal year. Mayor Pro-Tem Wayne Huffman made the motion to do the installation with the copper wiring in our next fiscal year. Councilman Clegg DeWalt 2<sup>nd</sup> the motion. All remaining members voted yea. Motion carried.
- **D.** Discussion and Action concerning the curb stops at the Post Office. Councilman Billy Goodin stated he's had several complaints about people tripping and stumbling at the Post Office. He observed that the curb stops are the same color as the freshly laid sidewalk and in the bright daylight it is hard to tell the difference. Mr. Goodin thinks the curb stops should be painted yellow to make it more noticeable. The Council has agreed to paint the curb stops and the curb yellow in front of the Post Office and to move 2 curb stops out so people will quit bumping the handicap signs. Councilman Billy Goodin made the motion to approve. Mayor Pro-Tem Wayne Huffman 2<sup>nd</sup> the motion. All remaining members voted yea. Motion carried.
- **E.** Discussion and Action regarding the proposed tax rate, take record vote and to schedule a public hearing. Mayor Pro-Tem Wayne Huffman stated according to the figures the tax office presented, the city normally increases the tax rate by 3% which is less than the rollback. This will make the tax per 100 be less than what it was this past year which was 0.006635 and the proposed tax rate is 0.006573. Mr. Huffman recommends going with the 3% adjustment and there will have to be 3 public hearings in regards to this. The meetings are schedule to be on August 28, 2014, September 4, 2014 and September 18, 2014 all at 6:00 p.m. Mayor Pro-Tem Wayne Huffman made the motion to go with the 3% adjustment. Councilman Clegg DeWalt 2<sup>nd</sup> the motion. All remaining members voted yea. Motion carried.
- **F.** Discussion and Action to hire Davis, Heinemann and Company to do the 2013-2014 Fiscal Year Audit. Mayor Pro-Tem Wayne Huffman made the motion to hire Davis, Heinemann and Company for the 2013-2014 fiscal year. Councilman Clegg DeWalt 2<sup>nd</sup> the motion. All remaining

members voted yea. Motion carried.

- G. Discussion and Action with Beth Newton concerning the owner's responsibility of the road condition passing to the buyer of the mobile home sale located on Avanna Lane. Ms. Newton stated she had the choice of paving Avanna Lane or putting rock on it but was told the city would not maintain the street if it was rocked. She is asking for approval to sell the property as is without having to gravel, pave or asphalt the road before she sells it. The Council told her that is between the buyer and herself. The council stated the street would have to be up to code to adopt the street in order to maintain it.
- **H. Discussion and Action with Ken Newton regarding bids for the demolition of inhabited houses.** There were 3 individuals who bid on the clean-up of properties which consists of mowing, clean-up and 1 garage demolition. Mr. Newton stated 3 property owners have agreed to pay the costs of their clean-up. Mayor Pro-Tem Wayne Huffman made the motion to award the bids to the lowest bidder of each property. Councilman Clegg DeWalt 2<sup>nd</sup> the motion. All remaining members voted yea. Motion carried. Riley Ogden got the bids at the following properties: 101 Lewis Street \$50.00, 102 Lewis Street \$50.00, 102 Emory Street \$200.00, 404 E. Madison Street \$200.00, 400 Block W. Madison \$200.00, 203 N. Elm Street \$100.00, 308 N. Kevin Street \$100.00, 104 S. Railroad Street \$60.00 and 400 Block N. Calvin Street \$200.00. Johnny English got the bids at the following properties: 500 Block W. Main at Emily Street \$125.00, 106 Washington Street \$75.00, Lot #6 Oak View Addition \$85.00 and 400 Church Street \$300.00.
