

ORDINANCE # 24-0012

AN ORDINANCE AMENDING ORDINANCE 23-0007 OF THE CITY OF TRINITY, TEXAS, ENTITLED SOLID WASTE REGULATIONS AND SERVICE CHARGE TO PROVIDE FOR ESTABLISHMENT OF NEW SOLID WASTE RATES; PROVIDING FOR ESTABLISHMENT OF MULTI-FAMILY AND/OR COMMERCIAL RATES; PROVIDING FOR A REPEAL OF ORDINANCES IN CONFLICT; PROVIDING A SERVERABILITY CLAUSE; PROVIDING FOR AN EFFECTIVE DATE; AND PROVIDING FOR A PENALTY FOR VIOLATIONS.

NOW THEREFORE, be it ordained by the City Council of the City of Trinity, that the following shall be set forth as the fees for solid waste.

SECTION I

SOLID WASTE REGULATIONS AND SERVICE CHARGES

- A. The monthly charge for solid waste disposal services for single residence customers for one service per week is \$19.93
- B. The following schedule of monthly charges for solid waste disposal services for commercial and multi-family customers is:
 - 1. Commercial hand pick-up one (1) time per week at the street or alley is \$34.08; and
 - 2. Dumpster charges will be based on size and number of times picked up per week according to the following schedule:

SECTION II

- C. All state mandated sales taxes shall be added to charges and forwarded to the State as required by law.

SECTION III

- D. These rates shall be effective beginning November 1, 2024.

SECTION IV

- E. All ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.


SECTION V

It is hereby declared to be the intention of the City Council that the sections, paragraphs, sentences, clauses and phrases of this Ordinance are serviceable and, if any phrase, clause, sentence, paragraph or section of this Ordinance shall be declared unconstitutional by the valid judgement or decree of any court of competent jurisdiction such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this Ordinance, since the same would have been enacted by the City Council without the incorporation of this Ordinance of any such unconstitutional phrase, clause, sentence, paragraph or section.

SECTION VI


- G. This Ordinance will take effect November 1, 2024 and the publication of this caption as the law in such cases provides.
